	0	Are otherwise unable to contact or locate their parents, and have not been adopted.
•	Documentation and may include, but is not limited to:	
	0	A documented interview between the student and the financial aid administrator;
	0	Submission of a court order or official federal or state documentation that the student or the student's parents or legal guardians
		are incarcerated in any federal or state penal institution;
	0	A documented phone call or a written statement, which confirms the specific unusual circumstances with:
		o A child welfare agency authorized by a state or county,

O Documents, such as utility bills or health insurance documentation, that demonstrate a separation from parents or legal guardians;
